



INDEMNITY FORM TO BE COMPLETED AND SIGNED BY PARENT/S OR LEGAL

I/we hereby release, agree to indemnify and hold the organisers and leaders, employees and agents free and harmless from any and all costs, losses, expenses, damages (direct, indirect, consequential or otherwise), claims, suits, causes of action or any other liability or responsibility whatsoever, including attorney's fees and related costs, resulting from any injury to any person(s) or damage to property arising out of, or which may in any manner be connected with, the conduct of our child while participating in the said Activity as provided for herein.

I/we further request that the leaders act "In Loco Parentis" during the said activity and consent herewith to them acting as such. I/we understand that in case of accident, injury or illness, which in the opinion of the organisers/leaders requires medical attention, the cost of this medical service or first aid attention will be my/our liability and at my/our cost.

I/we also give consent to use of appropriate photos of my/our child for reporting back purposes, where my/our child consents to such use. In this regard the organisers will subscribe to the provisions of the Protection of Personal Information Act [Act 4 of 2013]. I/we on the other hand also confirm that information of a personal nature provided is so provided voluntarily and may be processed and applied by the organisers.

***Acceptance***

By signing this agreement, the person/s signing confirm that he/she have read and understood the meaning and effect of this agreement and that he/she agree to be bound by it from the date of signature. If the person/s signing don't understand the meaning or effect of any of the clauses contained in this agreement, he/she/they should request that it be explained to him/her/them before accepting and concluding this agreement, by a person knowledgeable in such matters.

***General***

I/we agree that this agreement may be treated as a defence to any action or proceeding that may be brought, instituted or taken by anyone against the organiser/leaders.employees/agent for injuries and/or damages sustained as a result of participation in the Activity as described herein.

The person/s signing this agreement have read this agreement and understand all of its terms and executed this instrument voluntarily and with full knowledge of its significance.

The person/s signing this agreement confirm that he/she/they fully appreciate the risks that my/our child may be exposed to during his/her participation in the Activity and that the signatory/ies hereto voluntarily accept such risks.

The parties agree that this agreement may be signed electronically in terms of the Electronic Communications and Transactions Act 25 of 2002 (ECTA) and that in terms of ECTA, the agreement, in electronic format, is not without legal force and effect merely because it is wholly or partly in the form of a data message.
